#### STUDENT PAYMENT PLAN INFORMATION

Students may wish to manage their course fee payment in regular instalments or agreed payments. This can be achieved by application and approval of a Student Payment Plan.

On approval of a Student Payment Plan, you enter into a legally binding agreement to pay your fees by the due date.

#### **Payment Process**

- 1. An initial deposit must be paid on enrolment to confirm a place in the course
- 2. Payments can be accepted by the following methods:
  - EFTPOS
  - Online Payment
  - Direct Bank Transfer
  - Credit Card
  - Cash
- 3. Payment plans are either set up weekly/fortnightly to make regular payments or agreed amounts are paid on agreed dates as per My Flex Training Fees and Charges Policy
- 4. Government applicable enrolments (only)
