Venue



Classes will be held at 3/58 Anstruther Road, Mandurah. The venue is a 5 minute bus ride from Mandurah Train Station.

Course Delivery / Duration

This course is delivered in a classroom environment through face-to-face delivery. The duration of classroom delivery is 13 weeks. Work experience placement is in addition to this. Classes will be held 4 days per week (Mon, Tues, Wed, and Thurs) from 9am-2:30pm.

Work Experience Placement



You are required to complete a minimum of 120 hours of practical placement in an Aged Care Facility.

Generally, your work placement will be completed on the conclusion of the classroom delivery. My Flex Training will organise your work experience for you, unlike some other providers.



Entry Requirements



On enrolment, students will be asked to apply for both a National Police Clearance and Working with Children Check. These forms can be requested from our Training Administration Team.

Following industry standards, students will be required to provide proof of vaccination records and obtain a current flu vaccination.

Eligibility



All applications will be assessed by the My Flex Training Enrolment Officer on a case-by-case basis.

Students will be required to submit valid forms of photo ID, proof of citizenship/residency/visa status, and also complete a student enrolment form.

You are eligible for the course if you have left school, your primary place of residence is in Western Australia and you are:

- an Australian citizen;
- a permanent visa holder;
- a holder of visa subclass 309, 444, 785, 790, 820, 449, 826 and 786, which are currently used for Ukraine and Afghan nationals;
- secondary holders of a temporary visa of subclass 457:
- Holders of a Bridging Visa E (subclasses 050 and 051) where the visa holder has made a valid application for a visa of subclass 785 or 790.
- bridging visas holders who are not subject to condition 8101 and have made a valid application for a Permanent Protection Visa (subclass 866);
- secondary holders (spouses and dependents) of a Temporary Skill Shortage visa (subclass 482);

Course Fees



This course remains FEE FREE in 2024!

Tuition fees for the CHC33015 Certificate III in Individual Support (Ageing, Home and Community) are 100% funded by the government (for eligible students).

Course cost for students not meeting the eligibility requirements: \$2699.00

Student tuition fees are indicative only and are subject to change given individual circumstances at enrolment. Additional fees may apply such as Student service and resource fees.
